***DELTA FARMLAND & WILDLIFE TRUST CONDITIONAL***

**Winter Cover Crop Cost Share Agreement**

**BETWEEN THE CO-OPERATOR:** \_\_\_\_\_

**THE DELTA FARMLAND AND WILDLIFE TRUST**, a non-profit, community based, charitable society, whose mission is to promote the preservation of farmland and associated wildlife habitat in the Fraser River delta through sustainable farming and land stewardship (referred to hereafter as "DF&WT").

**WHEREAS:** The Co-operator and DF&WT have agreed to cost share the establishment of clover, winter cereals and/or spring cereals for the purposes of soil conservation and wildlife habitat enhancement in the Municipality of Delta, in the Province of British Columbia.

**THE CO-OPERATOR WILL:**

1. Plant a cover crop at a seeding rate appropriate to the crop type by an appropriate planting date (see attached cover crop fact sheet) within the fields identified on Schedule A of this agreement and return this form to the DF&WT office by **October 13, 2017**.
  - Seed spilt/blown from a combine during grain harvest that fulfills DF&WT management criteria, is eligible as a cover crop under the Cereal Habitat Enhancement Pilot arm of the Winter Cover Crop Stewardship Program. Residual grain fields matching this criteria should be enrolled separately from this agreement.
2. Allow DF&WT to monitor fields for wildlife use from October 14, 2017 to March 31, 2018.
3. **Ensure that plow down** of the cover crop **does not occur before March 31, 2018** unless DF&WT is advised of and agrees to an earlier plow down date.
4. Indemnify and save harmless DF&WT from and against any and all actions, suits, claims, demands, damages or losses, howsoever arising as a result of the establishment and operation of the Winter Cover Crop Program.

**THE DELTA FARMLAND & WILDLIFE TRUST WILL:**

- 1) share the cost of establishing cover crops within the Municipality of Delta, BC by paying between \$50.00 and \$55.00/acre for cover crops planted under the guidelines of the DF&WT Winter Cover Crop Program. Cost-share rates and planting guidelines can be found in Appendix A of this form and cooperators should thoroughly review the cost-share rates for 2017.
- 2) reduce the reimbursement by the same percentage for all acreage applied for, in the event that applications received by October 13, 2017 exceed available funds for the program.
- 3) make payment in late December 2017, after all agreements have been received with completed information and signatures from the Co-operator, and after the DF&WT has had the opportunity to verify all the acreage applied for.

## Appendix A

### IMPORTANT DATES



<b>August 14:</b>	Cut-off for planting forage grasses and clovers; all forage <i>grasses and clovers</i> must be seeded into standing grain to be eligible for the program
<b>August 31:</b>	Cut-off for planting <i>winter cereals</i> (winter wheat and fall rye) early to receive \$55/acre cost-share
<b>September 30:</b>	Deadline for planting frost-sensitive <i>spring cereals</i> (barley & oats)
<b>September 30:</b>	Deadline for planting <i>winter cereals</i> (winter wheat & fall rye; spring wheat included)
<b>October 13:</b>	Deadline for submitting Cover Crop applications to DF&WT office

Cover Crop Type	Rates for 2017 Program
<b>Frost-sensitive Spring Cereals</b> (barley, & oats)	Must be planted before September 30 <b>\$50/acre flat rate</b>
<b>Frost-tolerant Winter Cereals</b> (winter wheat & fall rye; spring wheat included)	Can be planted up to September 30 <b>\$55/acre* when planted before August 31;</b> <b>\$50/acre when planted before September 30;</b>
<b>Annual Ryegrass</b>	Can be planted up to September 30 <b>\$50/acre</b>
<b>Clover</b> (red clover, white clover, etc.) AND/OR <b>Forage Grass</b> (timothy, fescue, orchard grass, etc.)	Must be planted before August 14 <b>Clover and forage grass are eligible when under-seeded into grain crop</b> <b>\$50/acre flat rate</b> <b>Note: new forage plantings enrolled in the Delta Forage Damage Compensation Program are not eligible for the Winter Cover Crop Program</b>
<b>Spring-sown grain</b> that is not harvested	<b>\$50/acre flat rate</b>
<b>Spring-sown grain</b> that is harvested, and spilt grain germinates after harvest	<b>Eligible under Cereal Habitat Enhancement Program if grain is re-spread after harvest.</b> Please notify the Program Manager if you plan to re-spread grain over a harvested grain field.

\*All frost tolerant cereals (fall rye and winter wheat, as well as spring wheat) and annual forage grasses (annual ryegrass) will be eligible for a greater cost-share because they can provide live feed for waterfowl throughout the wintering period. Based on data collected during winter 2009/10, winter wheat may not be planted after September 30.
